## IMPORTING GOODS INTO THE UK AFTER BREXIT

Starting from January 1st 2021, the rules and procedures of importing goods from the EU have changed. It's convenient to understand the whole procedure in order to avoid any misunderstandings.

### The UK EORI number.

The very first step is to ensure that you have an active UK EORI number. If you already have a UK EORI number, you can check it's activity using the link below:

The UK EORI number is required in order to schedule an import clearance procedure. The set-up procedure is easy and free.

### Customs duties, taxes, and VAT.

Most of our goods are originating from Poland (EU) and fall under the duty Tariff preference. That means that on most of the goods that you will buy from FDOMES there will be no duties due. The items that fall under the Third-country Tariff are subject to the Import duties (Ask your Sales Manager about them).

### Necessary documentation and additional questions.

In order for the goods to pass the import clearance procedure, you'll need a few documents. The documents are:

- Commercial Invoice
- Packing list
- Movement Reference Number (MRN)
